## Election of the Executive Committee For the Year 2014-15

### **Election Results: Constitution of the Executive Committee**

Pursuant to the Bye-Law 31 and the sub-clauses included therein of the “Bye-Laws, Rules and Regulations” of the G C College Alumni Association, regarding election of members of the Executive Committee,

The Association held the elections for the membership of the Executive Committee on April 27, 2014 along with the general Body Meeting.

I, in my capacity as the Returning Officer for these elections, hereby inform all eligible core members of the Association that the elections were duly held, and my report and declaration are as follows:

1. I had received an adequate number of nominations for the positions open for election to the Executive Committee of the G C College Alumni Association;
2. However, in spite of extending the deadline for submission of nomination by a week, there has not been enough nomination to pursue a vote. For each of the positions to be elected, I had received only one nomination each;
3. I have completed scrutiny of the nominations received within the deadline for submission of nomination papers, and found all nominations submitted to be in order and to be valid in all aspects;
4. Thereafter, I had declared the names of the nominated members for the positions in the Executive Committee of the Association during the Annual General Body Meeting (as per the agenda circulated for the meeting) held on **April 27, 2014** (hereafter, referred to as “the Date of Election”), and invited the members present at the Annual General Body Meeting to raise objections, if any along with material evidence in support of such objections, with respect to the nominated members, nomination papers or the nomination papers submitted;
5. No objection whatsoever were raised by the members present in the Annual General Body Meeting with respect to the nominated members, nomination papers or the nomination papers submitted or any other matter;
6. Further, I declared the names of each elected member (based on the nominations received as per the due process) at the Annual General Body Meeting, and the members present accepted the results of the elections process by overwhelming voice vote.
7. Therefore, observing the due processes as laid down in the Pursuant to the Bye-Law 31 and the sub-clauses included therein of the “Bye-Laws, Rules and Regulations” of the G C College Alumni
